- on 9 April 2019 purchased 9 665 Issuer's treasury shares for an average price of PLN 0.891 per share. The total value of shares purchased amounted to PLN 8 611.70. The purchased shares constitute 0.00589% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 10 April 2019 purchased 11 016 Issuer's treasury shares for an average price of PLN 0.94 per share. The total value of shares purchased amounted to PLN 10 355.04. The purchased shares constitute 0.00672% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 11 April 2019 purchased 11 127 Issuer's treasury shares for an average price of PLN 0.925 per share. The total value of shares purchased amounted to PLN 10 292.49. The purchased shares constitute 0.00678% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 12 April 2019 purchased 10 160 Issuer's treasury shares for an average price of PLN 0.913 per share. The total value of shares purchased amounted to PLN 9 275.60. The purchased shares constitute 0.00619% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 176 015 shares, which constitute 0.10732% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
