- on 24 April 2019 purchased 3,222 Issuer's treasury shares for an average price of PLN 0.849 per share. The total value of shares purchased amounted to PLN 2,735.87. The purchased shares constitute 0.00196% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 25 April 2019 purchased 8,004 Issuer's treasury shares for an average price of PLN 0.872 per share. The total value of shares purchased amounted to PLN 6,978.96. The purchased shares constitute 0.00488% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 26 April 2019 purchased 8,024 Issuer's treasury shares for an average price of PLN 0.88 per share. The total value of shares purchased amounted to PLN 7,057.45. The purchased shares constitute 0.00489% of the share capital of the Issuer and votes at the General Meeting of the Issuer,

The total number of own shares held by the Issuer after considering the above transactions is 235,129 shares, which constitute 0.14336% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
