## **Subject: Purchase of own shares**

The Management Board of Ronson Development SE (the "**Issuer**") hereby announces that within the implementation of the share buyback program approved by the Resolution No. 3 of the Extraordinary General Meeting of the Issuer dated 24 January 2019 (current report No. 2/2019 dated 24 January 2019), the brokerage house, acting on the Issuer's account:

- on 8 July 2019 purchased 4,051 Issuer's treasury shares for an average price of PLN 0.900 per share. The total value of shares purchased amounted to PLN 3,645.90. The purchased shares constitute 0.00247% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 9 July 2019 purchased 2,554 Issuer's treasury shares for an average price of PLN 0.900 per share. The total value of shares purchased amounted to PLN 2,298.60. The purchased shares constitute 0.00156% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 10 July 2019 purchased 3,035 Issuer's treasury shares for an average price of PLN 0.885 per share. The total value of shares purchased amounted to PLN 2,685.98. The purchased shares constitute 0.00185% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 11 July 2019 purchased 2,387 Issuer's treasury shares for an average price of PLN 0.895 per share. The total value of shares purchased amounted to PLN 2,136.50. The purchased shares constitute 0.00146% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 12 July 2019 purchased 3,440 Issuer's treasury shares for an average price of PLN 0.886 per share. The total value of shares purchased amounted to PLN 3,049.40. The purchased shares constitute 0.00210% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 381,683 shares, which constitute 0.23272% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
