- on 26 August 2019 purchased 1,461 Issuer's treasury shares for an average price of PLN 0.869 per share. The total value of shares purchased amounted to PLN 1,269.27. The purchased shares constitute 0.00089% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 27 August 2019 purchased 903 Issuer's treasury shares for an average price of PLN 0.880 per share. The total value of shares purchased amounted to PLN 794.64. The purchased shares constitute 0.00055% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 28 August 2019 purchased 1,806 Issuer's treasury shares for an average price of PLN 0.862 per share. The total value of shares purchased amounted to PLN 1,556.25. The purchased shares constitute 0.00110% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 29 August 2019 purchased 1,112 Issuer's treasury shares for an average price of PLN 0.875 per share. The total value of shares purchased amounted to PLN 973.00. The purchased shares constitute 0.00068% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 30 August 2019 purchased 1,501 Issuer's treasury shares for an average price of PLN 0.880 per share. The total value of shares purchased amounted to PLN 1,320.88. The purchased shares constitute 0.00092% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 447,461 shares, which constitute 0.27282% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
