- on 24 September 2019 purchased 415 Issuer's treasury shares for an average price of PLN 0.834 per share. The total value of shares purchased amounted to PLN 346.20. The purchased shares constitute 0.00025% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 25 September 2019 purchased 2,564 Issuer's treasury shares for an average price of PLN 0.838 per share. The total value of shares purchased amounted to PLN 2,147.76. The purchased shares constitute 0.00156% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 26 September 2019 purchased 2,748 Issuer's treasury shares for an average price of PLN 0.840 per share. The total value of shares purchased amounted to PLN 2,308.32.
 The purchased shares constitute 0.00168% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 27 September 2019 purchased 2,839 Issuer's treasury shares for an average price of PLN 0.834 per share. The total value of shares purchased amounted to PLN 2,367.67. The purchased shares constitute 0.00173% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 487,899 shares, which constitute 0.29748% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
