- on 1 October 2019 purchased 2,570 Issuer's treasury shares for an average price of PLN 0.829 per share. The total value of shares purchased amounted to PLN 2,130.60. The purchased shares constitute 0.00157% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 2 October 2019 purchased 2,779 Issuer's treasury shares for an average price of PLN 0.837 per share. The total value of shares purchased amounted to PLN 2,326.22. The purchased shares constitute 0.00169% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 3 October 2019 purchased 2,794 Issuer's treasury shares for an average price of PLN 0.840 per share. The total value of shares purchased amounted to PLN 2,346.96. The purchased shares constitute 0.00170% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 4 October 2019 purchased 2,630 Issuer's treasury shares for an average price of PLN 0.838 per share. The total value of shares purchased amounted to PLN 2,204.20. The purchased shares constitute 0.00160% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 501,455 shares, which constitute 0.30575% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
