- on 22 November 2019 purchased 5,078 Issuer's treasury shares for an average price of PLN 0.814 per share. The total value of shares purchased amounted to PLN 4,133.18. The purchased shares constitute 0.00310% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 583,597 shares, which constitute 0.35583% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
