- on 25 November 2019 purchased 5,151 Issuer's treasury shares for an average price of PLN 0.815 per share. The total value of shares purchased amounted to PLN 4,198.07. The purchased shares constitute 0.00314% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 26 November 2019 purchased 5,175 Issuer's treasury shares for an average price of PLN 0.820 per share. The total value of shares purchased amounted to PLN 4,243.50. The purchased shares constitute 0.00316% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 27 November 2019 purchased 5,273 Issuer's treasury shares for an average price of PLN 0.821 per share. The total value of shares purchased amounted to PLN 4,328.86. The purchased shares constitute 0.00322% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 28 November 2019 purchased 4,918 Issuer's treasury shares for an average price of PLN 0.825 per share. The total value of shares purchased amounted to PLN 4,057.35. The purchased shares constitute 0.00300% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 29 November 2019 purchased 4,995 Issuer's treasury shares for an average price of PLN 0.823 per share. The total value of shares purchased amounted to PLN 4,110.90. The purchased shares constitute 0.00305% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 609,109 shares, which constitute 0.37138% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
