 The purchased shares constitute 0.00242% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 14 January 2020 purchased 4,207 Issuer's treasury shares for an average price of PLN 0.836 per share. The total value of shares purchased amounted to PLN 3,518.76. The purchased shares constitute 0.00257% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 15 January 2020 purchased 4,370 Issuer's treasury shares for an average price of PLN 0.840 per share. The total value of shares purchased amounted to PLN 3,670.80. The purchased shares constitute 0.00266% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 16 January 2020 purchased 4,365 Issuer's treasury shares for an average price of PLN 0.840 per share. The total value of shares purchased amounted to PLN 3,666.60. The purchased shares constitute 0.00266% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 17 January 2020 purchased 1,350 Issuer's treasury shares for an average price of PLN 0.850 per share. The total value of shares purchased amounted to PLN 1,147.50. The purchased shares constitute 0.00082% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 712,882 shares, which constitute 0.43466% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
