- on 30 July 2020 purchased 20,785 Issuer's treasury shares for an average price of PLN 1.317 per share. The total value of shares purchased amounted to PLN 27,375.50. The purchased shares constitute 0.01267% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 31 July 2020 purchased 13,064 Issuer's treasury shares for an average price of PLN 1.265 per share. The total value of shares purchased amounted to PLN 16,522.24. The purchased shares constitute 0.00797% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 894,607 shares, which constitute 0.54546% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
