- on 12 October 2020 purchased 6,351 Issuer's treasury shares for an average price of PLN 1.432 per share. The total value of shares purchased amounted to PLN 9,093.35. The purchased shares constitute 0.00387% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 13 October 2020 purchased 7,807 Issuer's treasury shares for an average price of PLN 1.418 per share. The total value of shares purchased amounted to PLN 11,073.32. The purchased shares constitute 0.00476% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
- on 14 October 2020 purchased 5,790 Issuer's treasury shares for an average price of PLN 1.443 per share. The total value of shares purchased amounted to PLN 8,353.78. The purchased shares constitute 0.00353% of the share capital of the Issuer and votes at the General Meeting of the Issuer,
- on 15 October 2020 purchased 2,978 Issuer's treasury shares for an average price of PLN 1.460 per share. The total value of shares purchased amounted to PLN 4,347.88. The purchased shares constitute 0.00182% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
- on 16 October 2020 purchased 2,200 Issuer's treasury shares for an average price of PLN 1.430 per share. The total value of shares purchased amounted to PLN 3,146.00. The purchased shares constitute 0.00134% of the share capital of the Issuer and votes at the General Meeting of the Issuer.

The total number of own shares held by the Issuer after considering the above transactions is 1,131,095 shares, which constitute 0.68965% of the share capital of the Issuer and votes at the General Meeting of the Issuer.
