RONSON Development publishes a financial report for the record-breaking sales year of 2023

- 1006 units sold in 2023 (vs. 441 in all of 2022) [+128% y/y]
- Delivery of 796 units in 2023 (vs. 745 in 2022)
- Company revenues from the sale of residential and commercial properties in 2023 amounted to PLN 395.5 million
- Operating profit in 2023 amounted to PLN 106.2 million (vs. PLN 48.5 million in 2022)
- Net profit in 2023 amounted to PLN 80.7 million (vs. PLN 31.4 million in 2022)
- 7 company projects are in progress 5 projects were completed during the year 2023 and are on sale (as of December 31, 2023 385 properties in the sales offer, including 47 in completed projects and 338 in projects in progress)
- LivingGo RONSON's institutional rental platform a land bank for 1,433 units in the company's possession

RONSON Development, one of the leading developers on the Polish real estate market, has published its financial report for 2022. The Company's revenues from the implementation of residential projects and services amounted to PLN 395,5 million, marking a 32% increase compared to 2022. According to the Management Board representatives, this growth is attributed to the delivery of a higher number of residential units. The Company's operating profit in 2023 amounted to PLN 106.2 million, compared to PLN 48.5 million in 2022. Net profit reached PLN 80.7 million, compared to PLN 31.4 million in 2022.

In 2023, RONSON Development sold 1006 units. Top selling projects among customers were: Ursus Centralny, Miasto Moje, Viva Jagodno, and Grunwald Między Drzewami. The company is preparing an additional 17 residential projects and 6 Build to Rent (PRS) projects. The company's land bank is secured for activity in the coming years.

— We are highly satisfied with the outcomes achieved in 2023. Our experience and flexibility have allowed us to successfully operate in a dynamically changing market environment. We maintained a high sales pace while simultaneously responding to the demand. As a result, our offering remained diverse and appealing, leading to a record-breaking 128% increase in apartment sales compared to 2022. — said Boaz Haim, CEO of RONSON Development. He added — Our attention is now focused on 2024, which has started off with a satisfactory level of sales. We are continuing at a high pace of development to respond promptly to the needs expressed by our customers.

Vice President Andrzej Gutowski also expressed significant satisfaction and optimism regarding the Company's results. — Dealing with such strong demand, especially after launching the Safe Credit 2% program last year, posed a challenge in managing our sales offerings effectively. Our goal was to maintain a wide and attractive range of options while adapting to cost-related changes in our environment. We achieved this remarkably well. He adds: — In 2024, we aim to maintain the results achieved in the previous year. We are steadfastly following through with our sales plans, regardless of any potential demand-supporting programs.

– We have achieved a record year financial result ending with high gross margin and high net margin, our cash flow standing is stronger than ever. We have demonstrated our ability to challenge ourselves with ambitious plans and achieving them with efficiency. The results of year 2023 put RONSON in excellent position in the opening of the year 2024. – said Yaron Shama, CFO of RONSON Development.
